- Your fee includes your session, print release, and a disk with all your best photos in it to use as you wish. Additional disks are available for \$25 each.
- Your **nonrefundable** deposit must be paid within 5 days of booking your session and the remaining balance is due before your session. If your deposit isn't paid within 5 days of booking your session it is automatically canceled. If you need to reschedule, you must contact me to do so. If canceled you will have two weeks to reschedule for your original deposit to apply to your new session. Cash, Check, Paypal, and Credit Cards are accepted.
- Returned checks are subject to a \$50.00 returned check fee. Client assumes responsibility for any and all collection costs and legal fees incurred by Brittany Myers Photography in the event that enforcement of this contract becomes necessary. All legal action shall take place in Amarillo, TX USA.
- If you decide to cancel my services for any reason, please let me know at least 30 days before your session date. Your initial deposit is non-refundable in this case, but any other monies paid up to this point will be refunded.
- Please be on time to photoshoot. If client is late I will not be able to shoot extra time due to scheduling conflicts.
- CREATIVE LICENSE- Images may be edited at the photographer's discretion, and delivered images may not include all images shot. The photographer reserves the creative right to edit and release only those deemed professional in quality and within the photographer's artistic standards.
- All images are copyrighted by Brittany Myers. It is illegal and unlawful to scan, copy, edit, or reproduce Brittany's work in any manner without written permission.
- Please be patient on delivery of completed photos. All CD's will be ready in a 2 week time period. I will contact you when CD is ready for pickup.
